On Monday, June 25, 2007, at approximately 1439 I responded to 130 Green Meadow Lane in reference to a Welfare Check.

I advised Dispatch I was unable to enter the property due to the auto-gate and 2 large K9s. Dispatch checked to find a neighbor that could take control of the K9s. Scheriper, Holly (110 Green Meadow Lane) was able to access the property and place the K9s in a cage. Lt. Alden (2123) and I made entry into the residence.

Juvenile was located in the upstairs, right bedroom, lying on the bed face down. Female was located in the family room on the main floor, lying on the floor. Male was located in the basement (weight room), sitting in an up right position. After the residence was cleared, CID was notified and responded to the scene along with Crime Scene. Fayette County Coroner was also notified.

Two K9s and several small kittens were turned over to Animal Control.

The Benoit family was found dead during a welfare check requested by the WWE. It was determined that Chris Benoit took the life of his wife, Nancy, on Friday, June 22, 2007, and then Daniel Benoit on Saturday, June 23, 2007. Christopher Benoit then took his own life on Sunday, June 24, 2007.
